### Dress Code

The following dress code applies to all members as well as all guests.

Clubhouse and Pro Shop

- **Jeans may be worn in the Clubhouse *but are not allowed on the course.***
- **Hats are not to be worn by male members in the upstairs part of the Clubhouse.**
- Shorts with tailored hems are acceptable and should be about knee length.
- All members must wear collared shirts or acceptable golf attire, check with the Pro Shop if in doubt.
- T-shirts, tank tops, belly shirts and cut-offs are not permitted in the Clubhouse.
- Soft spikes are permitted anywhere in the Clubhouse.
