## Playing Times

Tee times are allocated by an electronic lottery (ballot) system which is supervised by the Golf Shop, requests may be made up to 14 days in advance. Requests may be submitted online through the Clubs website, (silverspringsgolfclub.com) or in person on the tee time booking computers at the Club. Changes to requests or the actual tee times after the lottery has been done may be made online, in person at the tee time booking terminals or through the Golf Shop staff. Changes on the day of play must be made with the Golf Shop staff. Ballots for times during shareholder hours with less than three names are accepted without priority.

Ballots consisting of shareholders only will receive priority if demand for times within restricted areas is excessive. In the event of excessive demand for times during non restricted areas priority may be given as follows:

1. Shareholder ballot only
2. Shareholder and spouse/intermediate/junior
3. Spouse/intermediate/junior
4. Shareholder and guest
5. Spouse/intermediate/junior and guest

During periods of excessive demand, discretion may be used by the professional staff when adjusting ballots. Consideration is given to recent tee time history and frequency of play. Speed of play history will continue to be given consideration for times during shareholder hours on weekend and holiday mornings. Faster groups will be given priority for early times.

### Senior Shareholders

Monday through Thursday and weekend Club tournaments.

### Spouses and Intermediates

Can play following Shareholder times on Saturday, Sunday, and Holidays (usually after 11:00 AM and 11:30 AM).

### Juniors

We have 4 levels of Junior based on age (see Membership Dues for categories). Junior 3's and 4's are expected to have adult supervision and can ballot, with an adult, after 2:00 pm. Junior 1's and 2's can ballot anytime outside of league play and on weekends after 2:00 pm.

### Guests

May not play until 2:00 pm on Saturday, Sunday, or Holidays.

All guests will pay the applicable guest green fee.
